GENERAL RULES

Photographer

- **All first-place winners and major award winners are required to have a photograph taken by the official show photographer.**
- Requesting a photo to be taken by the official show photographer constitutes a contract between the owner and/or exhibitor and the photographer.
- Any first-place winner or major award winner who does not desire a personal copy of the win photo is required to advise the photographer of this fact at the time the photo is taken. Otherwise, the owner and/or exhibitor will receive a copy of the photo and will be held financially responsible for it.
- If at all possible, photographs are expected to be taken on the day the award is won.
- Any photo bill not paid within 60 days of the event is considered delinquent. GRCA and AGRC will do everything in their power to collect any unpaid invoices after that point.

RVs, Parking, Grooming, Etc.

General Information

- Security will be available from Sat., Sept. 24, 2011 through 12 noon Sun., Oct. 2.
- The buildings will be open from 6:00 AM to 11:00 PM.
- Food concessions are available at the show site Sat., Sept. 24, 2011 through Sat., Oct. 1.
- All buildings are No Smoking. Smoking is permitted outside the buildings.
- Dogs can not be left in the Exhibition Center (obedience/ rally building) overnight. Dogs can be left overnight in the grooming barns in crates only.
- Day Parking for cars is available at no charge.

Parking and RVs

- RV parking will become available at 9:00 AM on Sat., Sept. 24, 2011. All RVs must vacate the site by noon, Sun., Oct. 2. The fee for parking is \$225 for the entire Specialty.
- RV parking will be primarily on gravel surfaces. Most hookups include electricity; however extension cords may be required for connection. Water will be available; however "Y" connections and extra hose may be required. Very few sites will include sewer, however some sites will require a long sewer hose to connect. Septic pump-out will be arranged for a mid-week service, payment will be made directly to the service provider by the RV user at the time of the service. Additional information and sign-up will be available after arrival. A dump station is available at the facility; however please arrive with empty tanks if at all possible.
- Each RV will have an assigned space, RV parking will be limited to the spaces reserved, with no day-use RV parking available.
- Please arrive between the hours of 9:00 AM and 9:00 PM to ensure assistance in finding your assigned space. A map of assigned spaces will be made available for early or late arrivals, however anyone parking in an incorrect space will be asked to move.
- Confirmations will be sent via email only. Date received will be tracked to ensure special requests are met whenever possible.
- Reservations may be cancelled without penalty through August 15, 2011. No refunds will be available after that date. Please use email to cancel any confirmed reservation.
- There are approximately 100 RV spaces available at the facility. A waiting list will be maintained should more requests be received than can be immediately filled. Notification of waiting list status will be sent as soon as it is determined. Final determination of site availability will be made between August 15 and September 1. Refunds for reservations that cannot be accommodated will be processed after September 1.

- Dogs can be left over night in the grooming barns in crates only.
- Reservations are nonrefundable after August 15, 2011

Obedience/Rally exhibitors please note that all exhibitors, dogs crates and all equipment needs to be removed from the Horse Park-Exhibition Center obedience/rally building by 4:30 PM on Friday.

As a convenience for the obedience/rally exhibitors, the Exhibition Center obedience/rally building will be open between 3:00 PM to 6:00 PM on Tuesday, September 27th for the exhibitors to unload and setup. The Obedience/Rally building will open at 6:30 AM on Wednesday, September 28th; and 7:00 AM on Thursday, September 29th and Friday, September 30th. This building will be closed and locked after the completion of events and no dogs may be left in the building.

The obedience/rally committee will mark all crating space and only designated crating areas may be used. There should be adequate crating space; however, the trial committee has the right to move crates closer together so that everyone will have crating space. Please be considerate of your fellow exhibitors. Roping off or reserving unused crating space is prohibited. No Ex-Pens allowed.

There is ample parking close to the Exhibition Center, however please obey the unloading only and no parking signs around the area. There will be chairs available for obedience/rally spectators.

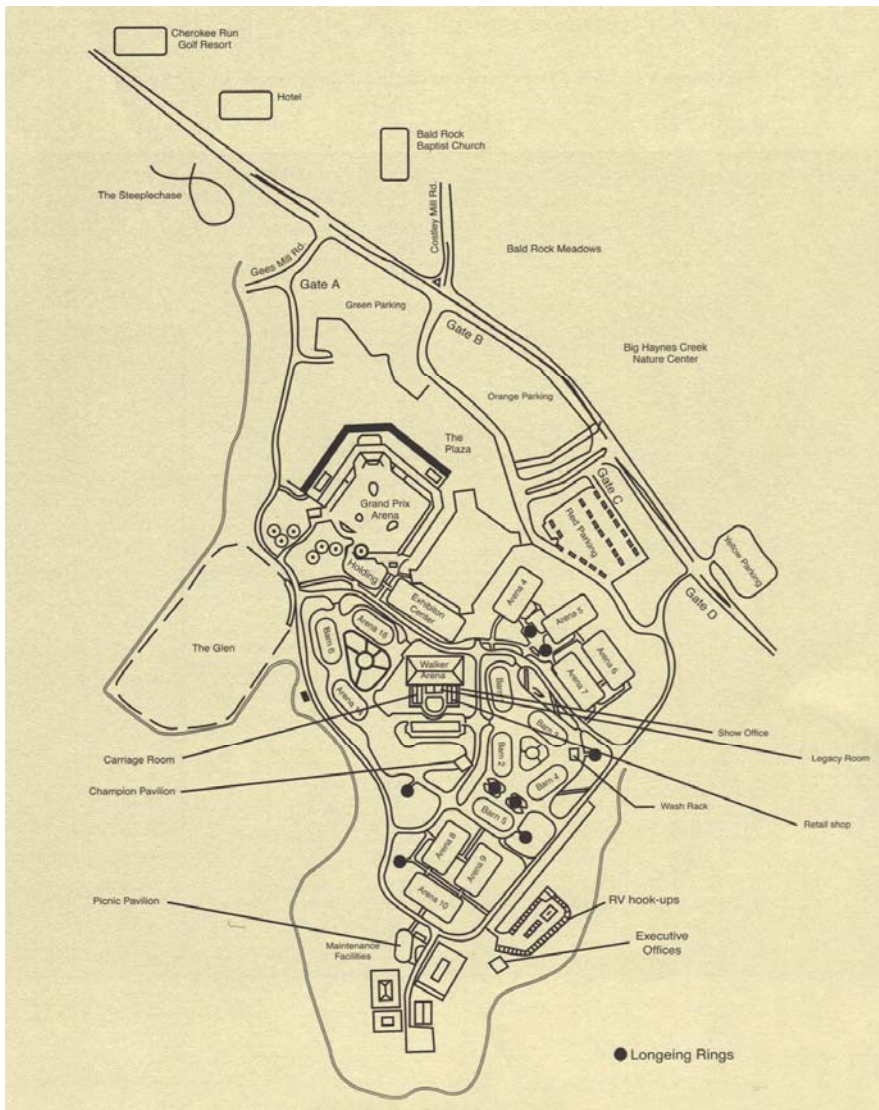

SITE MAP



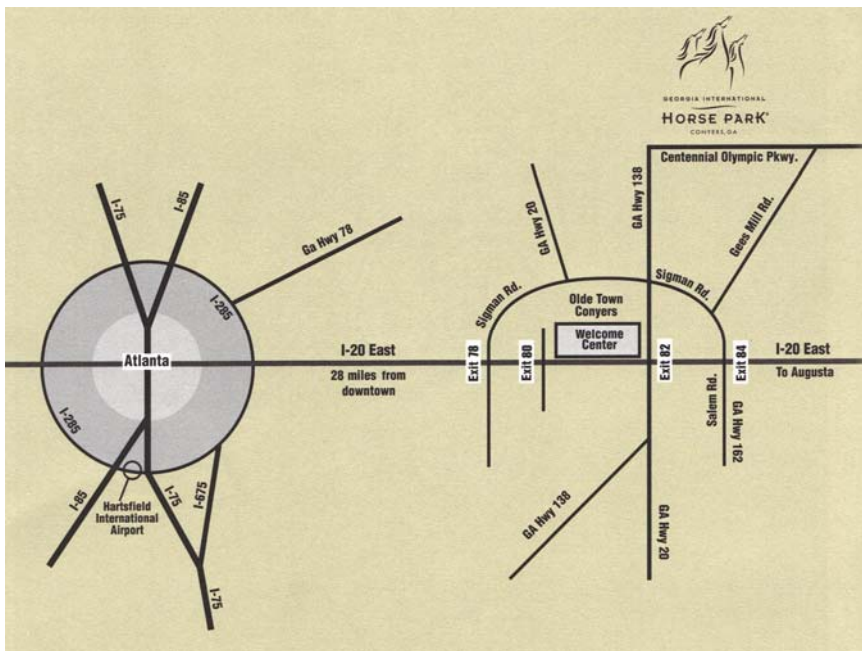
ROUTES TO TRIAL

The Georgia International Horse Park is located just 28 miles from the city of Atlanta.

Take Exit 82 off Interstate 20 in Conyers. Travel North approximately 4 miles. Turn right onto Centennial Olympic Parkway. The main entrance to the Park is 2 miles ahead on the right.

An alternative route to the Park is via Salem Road (Exit 84) off Interstate 20. Take Exit 84 and travel North approximately 1 mile. At Gees Mill Road, turn right and the Georgia International Horse Park Gate A is 2.5 miles on the right. To continue to the main gate (Gate C), continue past Gate A and turn right into Centennial Olympic Parkway. The main entrance will be on your right.
